Step One

Do you use Xero as your accounting software?

If so, then you can integrate your Xero account to provide spend data to cover GHG emissions from your purchased goods and services, and business travel.

What data will Trace access?	
Trace will only integrate expenses . We won't see any revenue, payroll (salary/super) or personal information.	
What if we don't use Xero?	
You can upload your accounting data via CSV at Step 4 - Map your spend data

Further to the attached CSV template (in the email), here are some helpful tips:

A list of expected emissions sources from purchased goods and services/business travel:

- Business travel (flights, accommodation, car hire, taxi, public transport)
- Professional services (e.g. recruitment, consulting, legal, engineering etc)
- Food and beverages
- Repairs and maintenance
- Building services such as cleaning
- Banking and financial services
- Marketing and advertising
- Office equipment and supplies

- ICT services and equipment (incl cloud services)
- Entertainment
- Products and materials
- Postage, courier and freight
- Clothing/uniforms
- Printing and publishing
- Contractors/labourers (not included in staff headcount on the location tab)

Formatting requirements for the CSV:

- Dates must be formatted as DD/MM/YYYY or YYYY/MM/DD
- Costs must be formatted as numbers, not currency (i.e. no commas)
- Each column must contain data, with no data gaps in the rows
- No additional data that the template doesn't specify

Step Two

Select your measurement period by choosing the last date of the 12-month period you wish to cover for your carbon assessment.

Add your Xero account as a data source, or upload your CSV data if you don't use Xero.

You will then need to "Map your Spend Data" to our emissions categories using the dropdown menus provided.

Once you click in to map your spend data, there is a short demo video available under "Helpful Tips". This exercise will cover the emissions from your **purchased goods and services**, as well as **business travel** if you don't have activity data for that.

Step Five

Once your spend data has been mapped, close that screen and click through to "Add your Activity Data".

Activity data (L, kWh, km etc) will cover emissions from your office **utilities** and **WFH energy** (on the Location tab), **employee commute** (on the Commute tab), **business travel*** (on the Travel tab), **fuel use** in company vehicles (on the Fuel tab) and **office waste** (on the Waste tab).

*Please provide **either** activity data or spend data for business travel, not both.

Step Six

Just kidding, there is no step six - you're done! Congratulations 🥳 - feel free to do a little victory dance before hitting **submit!**

Someone from our team will review your data and reach out with information on how to view your measurement breakdown, kickstart your decarbonisation plan, share your journey, and even offset your footprint if that's something you're interested in doing.
